Review of July Meeting Minutes	September meeting minutes available for review. Minutes were sent out via email & are posted on the Coalition website.	Reviewed by present members.
Hazard Vulnerability Analysis (HVA)	Rebecca gave a presentation on the hHAP (Health Hazard Assessment & Prioritization) tool, which is used to conduct the HVA. The HVA identifies our top hazards and guides HCSC activities. The top ten hazards along with the associated scoring were reviewed. The mitigation capacity of responder agencies for infectious disease was decreased from 3 to 2. This change will be reviewed by the Emergency Preparedness Steering Committee. A full revision on the HVA will occur during the 2019-2020 grant year.	None
Behavioral & Mental Health Impacts of Top 3 Hazards on Specific Populations	Michelle discussed the need to identify behavioral and mental health impacts of the top 3 hazards on children and older adults. Michelle will complete the matrix and send out for the coalition's review.	Provide input on the health impacts.
Statewide Medical Health Exercise After-Action Review	Michelle provided an overview of the Statewide Medical Health Exercise. She thanked the Closed POD partners for their incredible participation. One area for improvement is that Public Health could/should have used CAHAN (California Health Alert Network) to alert Closed POD Partners. Roundtable	<p>Michelle Jachetta – Calaveras County is offering advanced ICS 300 & 400 for free. Region IV Statewide Medical Health Exercise was the week of November 5-9, 2018 and involved a regional response to an antrax attack.</p> <p>Kris Amorino – Home health's Clovis office participated in the SWMHE. Joint Commission approved the Sonora office's disaster plan.</p> <p>Randy Hancock – will be participating in EMResource drill.</p>	

Todd McNeal – activating resources to go to Butte County. THA-CERT is open to anyone in the county.

Jeff Millar – The PG&E Wildfire Safety Program has two components that impact Tuolumne County: enhanced tree trimming and the Public Safety Power Shutoffs. PG&E Public Safety Power Shutoffs have occurred twice this fall – one in October and a second this week; they are significant for health care and at-risk populations. PG&E will contact OES, Sheriffs, and CalFire as soon as they decide to implement a shutoff. Their goal is to start notifications to the public 72 hours before a shutoff, with a final notification advising that power will shut off within the next 12 hours. PG&E does not know how long power will stay off – it depends on the length of the weather event. All de-energized lines have to be physically inspected before turning the power back on.

Neil Evans – Participated in the HazMat tabletop exercise at the hospital. The Sheriff's Office has talked about triggers for sending out a Citizen Alert regarding a PG&E Power Shutoff.

Jad Kurdi – The Winter OA meeting is on November 9. OES will be participating in a MotherLode Views about winter preparedness.

Lise Lemonnier – Recently held firefighter rehab training.

Suzan Greenwood – ICES provides support to families who use childcare. ICES is trying to support and train childcare providers on emergency preparedness. State licensing has minimal requirements for emergency preparedness, so ICES is trying to make it easy for providers to implement higher levels. Thousands of children under 5 are away from home each day.

Kathleen Hill – ATCAA head start provides care for the 0-5 population. Looking forward to taking info from this meeting and implementing in their programs.

Gary Caldwell – Adventist Health is opening some new clinics and rearranging departments in the process. The Closed POD exercise was a great opportunity for communication practice. Regarding PG&E Power Shutoffs – Public Health would need to release food safety messaging.

Lawrence Moradkhani – Has been working for Avalon Sonora for one month. Making sure plans are up-to-date.

Pandora Armbruster – Is the Safety Coordinator for Behavioral Health. Currently working on in-house safety and response to biohazard impacts out in the field. Updated meds fridge.

Catherine Driver – Catholic Charities' role would be to support however they are asked to. As an ombudsman, she would like to be involved in facilities and their plans.
